### **1) Scope**

This Privacy Policy applies only to this landing page (the “Site”). The Site provides brief marketing information, asks visitors to confirm they meet an age requirement, and may direct visitors to our main website. Our main website and membership services may have separate terms and privacy disclosures.

### **2) Information we collect**

#### **A. Information you provide**

- Age confirmation: If you click “Start My Journey” (or similar), we may record that you confirmed you are between 18 and 35 years old.

#### **B. Information collected automatically**

When you visit the Site, we (and our service providers) may collect:

- Device and browser information (e.g., device type, browser type)
- Usage data (e.g., pages viewed, clicks, time on page)
- Log data (e.g., IP address, approximate location derived from IP, referral URL, timestamps)

### **3) Cookies and analytics**

We may use cookies and similar technologies to operate the Site and understand its performance. If enabled, analytics (such as Google Analytics) may use cookies to collect information about how visitors use the Site.

You can control cookies through your browser settings. If we implement a cookie banner or “Cookie Preferences” link, you can manage optional cookies there.

#### **4) How we use information**

We use information to:

- Operate and secure the Site
- Record and enforce the age-audience confirmation
- Measure Site performance and improve the visitor experience
- Detect and prevent fraud, abuse, and technical issues

#### **5) How we share information**

We may share information:

- With service providers (hosting, security, analytics) who process data on our behalf
- For legal reasons (to comply with law, enforce policies, protect rights and safety)

#### **6) Data retention**

We keep information only as long as necessary for the purposes described above. Analytics retention is controlled by the settings in the analytics platform and may be retained for reporting and security purposes. The website “<https://www.Viagoy.com>” does not store your Birthday data. This data is only used to confirm the age requirements.

#### **7) Children’s privacy**

This Site is intended for individuals 18–35. We do not knowingly collect personal information from anyone under 18. If you believe a minor has provided personal information, contact us at the email below.

We use reasonable safeguards designed to protect information. No method of transmission or storage is completely secure.
